*Note: The first payment of \$300.00 is a non-refundable deposit to be made within 30 days from receipt of your acceptance letter or this document. If you have already paid the \$300 deposit, we thank you for your payment.

The Total Fee for Off-Campus Study Programs is broken down as follows:

- ➤ \$33,807 Tuition
- > \$9,045 Program Fee*
- ➤ \$37 Health and Wellness Fee**

*Included in the program fee are room/housing, board/meals, field trips, administrative fees, and supplemental health insurance. Not included are airfare, passport and visa expenses, primary insurance coverage, photographs, books, immunizations, and incidentals.

**The Health & Wellness Fee supports the operations of Wellness Services staff in delivering pre-program orientation services, as well as in providing health-related consultation regarding participant health needs. All students in the College of Arts and Sciences pay a mandatory fee of \$37 per semester. The fee will be waived for non-Lewis & Clark participants.

Withdrawal of Participant:

If a participant withdraws from a Lewis & Clark Overseas Program, or is dismissed from a program, the following fees will apply:

If the participant withdraws three months or more before the beginning of the semester, the participant is responsible for the \$300 non-refundable deposit.

^{**}Payment is due in full by above deadlines unless semester costs are being made through the monthly payment plan with Tuition Management Systems.

If the participant withdraws less than three months before the beginning of the semester, the participant is responsible for a withdrawal fee of \$3,000, which includes the non-refundable deposit.

If the participant withdraws at, or after, the beginning of the semester, in addition to the \$3,000 withdrawal fee, tuition and program fees will be prorated on a per-day basis, up to the 60% point in the semester. After the 60% point in the semester, charges for tuition and program fees are not adjusted.

The Overseas & Off-Campus Programs office and the Student and Departmental Account Services offices will determine the participant's withdrawal fee based on the Lewis & Clark College of Arts & Sciences academic calendar, regardless of the actual program dates.

The College reserves the right to add any fees the participant incurs to their student account, and to withhold diplomas for outstanding balances. This may include, but is not limited to, non-recoverable expenses or fines for damages. Participants who have not settled their accounts will not be allowed to register or attend classes for future semesters. Once you are registered for your Overseas Study Program, the Tuition and Program Fee will be charged to your student account. At that point, your account will be pulled into Student and Departmental Account Services' regular schedule of statements.

The Fall 2025 deadline to settle your student account is: August 2025. The Spring 2026 deadline to settle your student account is December 2025. Thereafter, monthly statements will be generated if, for one reason or another, your account is carrying a balance due to the school.
